In strict adherence, compliance, and based on Article 24 of the General Provisions Applicable to Entities and Issuers Supervised by the CNBV who engage Basic Financial Statements External Audit Services (the “Provisions”), Ing. Luis Eduardo Barrios Sánchez, a duly accredited individual before the Commission representing Hoteles City Express, S.A.B. de C.V. (“City Express”), hereby informs that the Company’s Board of Directors at its meeting which took place on July 22<sup>nd</sup>, 2020, unanimously approved upon the recommendation of the Audit, Risk, and Corporate Practices Committees, the replacement of the firm **KPMG Cárdenas Dosal, S.C. and subsequent hiring of the firm Galaz, Yamazaki, Ruiz Urquiza, S.C. (Member of Deloitte Touche Tohmatsu Limited)** as the providers of External Audit services for the Basic Financial Statements of the Company and its Subsidiaries. This is effective as of the current year (2020). In the same meeting, the appointment of C.P.C. Manuel Nieblas Rodríguez as the person responsible for issuing and signing said audit report was approved, in accordance with Article 24 of said Provisions.
